Essential Duties and Responsibilities:

Walk mowing greens
Identify and remove invasive weeds from native plant areas
Fill divots and fix ball marks
Shop cleanup- pressure wash, mop, sweep, vacuum, dust, clean windows, etc.
Utilize hand tools such as shovel, rake, broom, tamp, etc.
Operate four-wheel utility cart and Cushman work vehicle
Edge, rake and prep sand bunkers
Minor tree trimming

Equipment Operation Requirements:

Walking greens mower
Fly mower, weed eater, edger, hand blower, push mower, hedge trimmers, and pruning loppers
Hand tools such as shovel, rake, broom, tamp, leaf rake
Buffalo blower
Collar mower
Four-wheel utility vehicle
Bunker rake
